Participants

Participation in the Airbus Sloshing Rocket Workshop is limited on a range of two(2) to six(6) people per team.

Participants in the competition include EUROAVIA members and non-EUROAVIA members with an academic degree ranging from a bachelor's to a master's.

Application rules

To apply as participant of the event, you must fill the google form available on the website https://sloshing.euroavia.eu/regulation-2025/ or click on this https://forms.gle/WAsUizPpHzHJfTsE7

20th of December 2024 at 12:00 UTC

The applications open.

The applications are processed in a "first come- first served" way.

24th of January 2025 at 12:00 UTC

The applications close.

Application Procedure

Only the team leader shall submit the application.

In the event of any missing information or inconsistencies in the Intellectual Property declaration, the organization will contact the team to address the issues.

Once the team application is submitted, the team leader will receive a **confirmation of application email**, which does not mean that the place of the team in the competition is secured.

Acceptance Procedure

After the applications are processed, the respective team leaders of the selected teams will receive an email confirming their acceptance and further information on the payment of the participation fee and an Intellectual Property declaration to sign by a representative of the team. The acceptance Procedure is only concluded after the participation fee is paid. A proof of payment must be provided within the first 72h after receiving the acceptance e-mail. Same rule applies to the Intellectual Property Document.

In the case where the payment is to be done by an external organisation (e.g., University sponsoring the team) with a consequent delay, an additional period for this payment may be granted under the condition of signing a declaration of honour and providing a justification of this matter.

Payment

The participation fee is personal (per person per team) 25€ (EUR 25) for EUROAVIA members and 50€ (EUR 50) for non-EUROAVIA members.

The payment information regarding the participation fee will be provided to the participants via email by EUROAVIA International, once confirmed.

Cancellation rules

In the case that a member has been confirmed by the organizing committee to participate in the Airbus Sloshing Rocket Workshop 2025 and paid the participation fee, but, for any reason, is unable to participate in the event, the member will have to send an email to sloshing@euroavia.eu stating their cancellation.

A member who has already been confirmed and paid the participation fee is not eligible for a refund.

In case that a team decides to cancel its participation, they also need to inform the organization by sending an email to **sloshing@euroavia.eu** stating their cancellation.

After their cancellation is processed, the spot will go to the next team in the rankings and cannot be returned.

Changing of team members

The replacement of team members is allowed during the competition; however, the process requires the following steps:

- The new team member shall approve the Intellectual Property declaration.
- The new team member has 72h after receiving the confirmation e-mail to pay the participation fee. This fee is reduced by half in case this new member joins after the submission of the team's midterm report:
 - 13€ (EUR 13) for EUROAVIA members, after the submission of the team's midterm report,
 - o 25€ (EUR 25) for non-EUROAVIA members, after the submission of the team's midterm report

- If the new team member joins after the submission of the team's midterm report, their entry will be made through a replacement, meaning they will need to replace an existing team member.
- In case of a replacement as mentioned in the topic above, the team member who is replaced is not entitled to the refund of the participation fee.
- The team can increase in size until before the team's midterm report delivery, up to six(6) members max.
- After the team's midterm report delivery all changes in the composition must not change the size of the team.

Important remarks:

- 1. EUROAVIA International will verify the membership status for every member in every team and reserves the right to issue the extra fee to each non-EUROAVIA or inactive EUROAVIA member

- 2. The participation fee allows each participant attending the webinars offered by Airbus and other collaborators. For the finalist teams, all the costs will be covered regarding the accommodation, food and transportation between the accommodation and the venue of the event during the days where the final of the competition will take place. Additional costs such as transportation to the city and/or extra nights/food will not be covered by the organisation of the event.
